## Indonesia - advancing knowledge and traceability within the FIP.

Last month IPNLF staff Martin Purves (Fishery Development Director), Alice Miller (Social Research and Programme Director) and Ian Scott (Special Advisor) journeyed to Bitung, Indonesia to join Andrew Harvey (Indonesian Country Director) to support Asosiasi Perikanan Pole and Line dan Hand Line Indonesia (AP2HI) in the first Training of Trainers workshop.

AP2HI invited a representative from each of its 12 member pole-and-line and handline fishery organisations to the workshop. The objectve was to increase participants' knowledge of the Marine Stewardship Council (MSC) certification and fisheries improvement project (FIP) processes and equip them with the learning tools and resources to take back to their companies. Training focussed on five thematic areas: sustainable

fishing practices, product quality and handling, bait handling, safety at sea and the MSC standard and certification process. The 'training of trainers' program target is to have 500 fishers across the country trained by the end of the year, thus improving the sustainability, quality and profitability of Indonesia's one-by-one tuna fishery catches.

Within the same trip the team attended the inaugural application of <u>ProActive Vessel Registration (PVR)</u> stickers upon Indonesian one-by-one tuna vessels. This new scheme will see small-scale vessels registered on the <u>ISSF database</u>, enabling purchasers to access information about the vessel's credentials and commitment to sustainability – creating a more transparent supply chain.

#### What do the WCPFC scientific committee outcomes mean for IPNLF?

IPNLF's Policy & Advocacy Advisor, Adam Baske, attended the 11<sup>th</sup> Scientific Committee for the <u>Western and Central Pacific Fisheries Commission (WCPFC)</u> in early August, along with 200 fisheries scientists and managers, with the objective of developing scientific recommendations to end or prevent overfishing of tuna and other highly migratory species in the western and central Pacific Ocean.

Adam was particularly keen to find out what the latest science and management advice meant for the one-by-one tuna fisheries. Topics covered included current health of tuna stocks, reference points and harvest strategies, management of bycatch and data
